Dear Secretary Byrd,

"The stakes for rooting out election fraud and malfeasance are extremely high as even a minor corruption in the elections process threatens the constitutional representative government." – Cord Byrd

Secretary Byrd, there is very strong belief by the vast majority of MAGA Republicans backed by substantial information and evidence that there is MAJOR corruption in the elections process, and therefore, I am requesting that you take the following immediate actions to help suppress the voting fraud and restore public confidence in the Florida voting systems:

- Issue a letter to all the SOEs stating that the digital ballot images are election materials and by both Florida and Federal law cannot be deleted for 22 months. Instruct the SOEs to post these images on the Internet.
- Issue a letter to all the SOEs stating that due to emergency circumstances the manual audit of the voting machine counts can no longer be used, 101.591(2)(a). All counties are required to use the automated audit 101.591(2)(b). Inform the SOEs that the Department of State will perform the audits if they do not.
- Challenge the VBM ballots of everyone who: 1) Has notified the Postal Service that they
  have moved or their post cards have come back as non-deliverable, 2) Does not have a real
  address per the Postal Service, 3) Does not have a valid address. For example, the voter
  refused to give their apartment number when they registered. VBM ballots cannot be
  delivered to invalid addresses and it is a violation of chain of custody rules to do so.
- As the Chief Election Officer for the State of Florida actively press the county Sheriffs to follow state law and their oath of office. 102.091(1) The sheriff shall exercise strict vigilance in the detection of any violations of the election laws and in apprehending the violators.

### Additional Detail and Background Information

#### Shutting down the voting machine fraud by insiders and other groups.

Issue a letter to all the SOEs stating that due to emergency circumstances the manual audit of the voting machine counts can no longer be used, 101.591(2)(a). All counties are required to use the automated audit 101.591(2)(b). Furthermore, some counties will be randomly selected for recounts by the Secretary of States Office and any county which does not do an automated audit to the Secretary of States satisfaction will have the audit done by the Secretary of States Office. The SOS will conduct these audits by following the procedures in 101.591(2)(b) and trucking the ballots to be recounted to a county with the proper equipment and trained personnel to do the audit. For example, Mark Anderson of Bay County.

Basis for the emergency declaration: There is a mountain of readily available evidence to show that the voting machines can easily be tampered with and have the built-in capabilities for insiders who are bad actors to easily change the vote totals. This information has been so widely published throughout the country that the majority of all Americans and the vast majority of MAGA Florida Republicans believe that the voting machines can no longer be trusted.

The authority for the Secretary of State under 97.012(3) can be used to authorize the audits done by the SOS:

**97.012** (3) Actively seek out and collect the data and statistics necessary to knowledgeably scrutinize the effectiveness of election laws.

Additional authority for the SOS to take action: There is more than a reasonable basis for the Secretary of State to believe that there is widespread voting fraud across the state. The Florida Department of Law Enforcement is saying that this is true:

"It has been well known in political science circles that we have a problem with ineligible voters casting ballots in this state and nothing has been done about it until now. It is awfully unfair to the supporters of political candidates, the candidates, and the public at large that this sort of thing has been allowed to go on." - Pete Antonacci at the governor's press conference.

In addition. there is a tremendous amount of information that has been produced by various civics groups that show widespread fraud. I have at least 2,000 cases of people voting out of private mailboxes across the state, a third-degree felony as it involves lying about where you live in the registration process. Defend Florida spent over 150,000 man hours tracking

down people who voted in 2020 but had not voted in a while. They found a 20% fraud rate in this sample. These are mostly people who are voting out of places where they don't live because they moved, they were dead, or you could not live at that address. Lake County did a much more extensive review and made a serious effort to track down more details about their cases. Lake County is actually a pretty good county. In other words, not much fraud would be expected out of Lake. For example, they only have a handful of people voting out of private mailboxes. In Broward there are over 800. What this means is that if you project the fraud rate from Lake across the entire state, you will almost certainly get a number that is actually lower than the true fraud rate, but the key issue is that this will still be a massive amount of fraud. Furthermore, St. Lucie County just recently did an in-depth review of the voting of convicted felons. After a very serious effort they came up with 150 felons that they believe voted illegally. In Sarasota County they ran a list of 14,000 people who got out of jury duty by claiming to be non-citizens against the registration database. Many thousands of these people voted. They also checked a list of about 1,500 felons. About 1,000 were registered and about 400 to 500 voted. These numbers are currently being vetted, but projecting these numbers across the state shows a massive level of fraud.

Refer to the two documents I gave you at the Cleta Mitchell Voting Integrity Summit in March of this year. "Closing Loopholes and Resolving Conflicts" shows how the state laws have been systematically corroded and corrupted by special interests in order to game the system to their advantage. A major reason why there are so many problems with the existing system is that that the laws are so badly written that they make it very hard for the good people to do their job. I had several debates with the lawyer representing the Supervisors of Elections Association in Tallahassee. This guy was, in practical terms, openly and aggressively championing voting fraud. "Florida Voting System County Level Control Metrics -- Part 1" shows how 24 major counties all do things differently. Almost universally they don't follow the postal service Publication 28 specification and requirements for addresses. If the SOEs can't and don't want to get the addresses right on their mail, how in the World can we trust them to count the votes properly. The bottom line here is that the system is really screwed up for a lot of obvious reasons that are actually pretty straightforward to fix. But, for you the main point is that I don't think you are going to be able to cover all this stuff up. Which means, in the end, YOU are the one who is going to get blamed. Sit back, don't do anything, try to ride things out, cover things up. Well, it's just not going to work. And there goes your job and your career.

# The Digital Images of the Ballots are Election Materials and Must be Preserved for 22 Months According to State and Federal Law

The ES&S voting machines have a switch setting (AS I HAVE READ IN THEIR MANUALS) that will automatically delete the digital images of the ballots. These images are election materials and by law must be preserved. The reason why the machines have this design feature and the reason why it is used is so that the public cannot count the ballots and expose the fraud. Simply enforcing existing law, would go a long way toward putting a break on the voting

machine fraud. If the bad guys knew that the public could get copies of the ballots from the Internet and count them up, they would realize that they could not get away with their fraud schemes. Simply issue a letter or write a rule requiring the digital images be preserved and that they be posted by precinct of each county web site.

#### **Suppressing the Vote-by-Mail Fraud**

Our guys are working on running the TrueNCOA lists against the request for VBM ballot lists with the objective of openly challenging the VBM ballots of people who are voting out of places where they no longer live. You could do that. You could run the whole state and insist that people have to vote from their address of legal residence, which is what the laws says. You could drop the extraordinarily corrupt ERIC system and force the SOEs to use the TrueNCOA data or just get the change of address information directly from the Post Office. At a bare minimum you could instruct the SOEs not to send VBM ballots to people who have notified the Post Office that they have moved. You could also insist that the SOEs not send VBM ballots to anyone who lives in a apartment but has refused to give their apartment number when they registered to vote. Insist that they vote in person and give their apartment number when they show up. You could write, according to specific provisions in state law, chain of custody rules that would curtail a lot of this corrupt and illegal activity. You could insist that the SOEs send bipartisan voting teams, per existing state law, out to nursing homes. This is an area that is widely known for rampant voting fraud. For you to refuse to take action to protect the voting rights of our most vulnerable citizens is unconscionable. Again, the fact that this type of fraud is widely tolerated is a striking example of tolerating unacceptable behavior.

#### **Getting the Sheriffs to do Their Jobs**

The Sheriffs are first in line in state law to enforce election laws and have sworn an Oath of Office that requires them to enforce the laws. The Sheriffs, in general, are engaged in gross dereliction of duty. Please refer to the letter and extensive package of information I sent you about this issue. It is a misdemeanor in state law for the Sheriffs not to enforce election laws. As the Chief Election Officer, you are also responsible for this and should be aggressively pressing the Sheriffs to do their jobs.

#### The Road to Ruin is Tolerating Unacceptable Behavior

Up next is a quote from Jordon Peterson about how the road to ruin starts with the tolerance of unacceptable behavior. For example, the Florida County Sheriffs refusing to enforce election law.

Jordon Peterson in a YouTube interview: "You can convert kids, surgically. **So tell me how we** can be having this conversation, even. It's just beyond comprehension."

Interviewer, "I think people have very different views. People a lot just want to tolerate it and say, this is fine."
